In producing herewith one arrested accused person namely Subhankar Barman @ Subho (19) S/O Gopal Barman of Hossainpur Sanyas Colony, PS- Balurghat, Dist- Dakshin Dinajpur along with seized article i.e. 1) Total 1200 sealed bottles containing 100 ml each of Codeine Phosphate & Chlorpheniramine Maleate Syrup - Fairdyl (batch No.ZS20012, MFG date. 07/21, EXP. date. 06/23, MRP Rs. 168/-) recovered from Ten (10) cartoons, each cartoons contains 120 bottles of Codeine Phosphate & Chlorpheniramine Maleate Syrup - Fairdyl. (2) One health card of Gouri Barman D/O Jyostna Barman W/O Gopal Barman of Hossainpur, PS- Balurghat (3) One Printed bedshit (4) Photocopy of Jobcard vide No.WB/170100619070 (5) Ten numbers of cartoons to the effect that today i.e. on 27/04/2022 at 17:45hrs. I SI Patrick Kerketta received source information that some smugglers of Balurghat have stock huge phensedyl at the house of one Gopal Barman S/O Dulal Barman of Hossainpur, PS- Balurghat, Dist- Dakshin Dinajpur for the purpose of smuggling into Bangladesh toward Hili BD boarder side illegally and there is a chance of recovery of the same.

I perused the source information to I/C Balurghat PS and diarized the information into PS GDF which refers to Balurghat PS GDE No.1777 dated 27/04/2022. I/C Balurghat PS directed me to work out the information accompanying with Evening Van Officer. Accordingly, I SI Patrick Kerketta along with force C/737 Pranab Das and Civic Volunteers ID/843 Sudip Mahanta, ID/575 Piter Surin, ID/434 Manaranjan Barman, ID/515 Nityananda Mahata, ID/46 Amit Mandal, ID/83 Anup Paul vide Balurghat PS MCC No.1458/22 dated: 27.04.2022 and GDE No.1780 dated: 27.04.2022 left for village Hossainpur to work out the veracity of information by Govt. vehicle No. WB24R/7873

accompanying with Evening Van Officer SI Debasish Kundu and his force.

We reached at vill- Hossainpur area at 18:20hrs and I managed independent disinterested witnesses from the locality namely 1) Sourav Paul (19) S/O Manoj Paul (2) Ratan Chowdhury (45) S/O Lt. Shib Charan Chowdhury both of Hossainpur Sanyas Colony, PS- Balurghat, Dist- Dakshin Dinajpur for co-operating with Police party during search & scizure as witness. On being briefed and requested they agreed to co-operate with Police party.

After that we proceeded towards the house of Gopal Barman keeping the vehicle into a considerable distance. On reaching near the house of Gopal Barman, we noticed that some persons are loitering there but seeing the police party, they started fleeing from the said house. But after a hot

chase we managed to apprehend the above noted person.

On interrogation he made different statement in different time and he made dissatisfactory answers which leads to great suspicion that he along with others were fleeing from the house to hide their illegal purpose. Later on he disclosed his name and identity as noted above and also confessed that some cartoons containing phensedyl have been kept in the bedroom of his father Gopal Barman. On being identified the bedroom of Gopal Barman, I cordoned the said room with Police party.

Thereafter, I informed Sri. Bikash Dutta, I/C Balurghat PS and requested him to arrange one Magistrate for search, seizure and for further procedure and also one Photographer. After sometimes I/C Balurghat PS informed me that requisition for one Executive Magistrate has been sent to SDO,

Balurghat, till the arrival of Executive Magistrate, he asked me to cordon the house.

Finally on 27.04.2022 at 21:05hrs Sri. Dipankar Roy, WBCS(Exc.), Executive Magistrate. Before opening the room and search, we asked him to search police party, witnesses, Executive Magistrate including vehicle but he denied doing the same. I also served him notice in this regard. In presence of Executive Magistrate, witnesses and apprehended person, the bedroom is being opened and found that Ten (10) cartoons were covered with one printed bedshit and on being open and search the cartoons total 1200 sealed bottles containing 100 ml each of Codeine Phosphate & Chlorpheniramine Maleate Syrup - Fairdyl (batch No. ZS20012, MFG date. 07/21, EXP. date. 06/23, MRP Rs. 168/-) recovered from Ten (10) cartoons, each cartoons contains 120 bottles of Codeine Phosphate & Chlorpheniramine Maleate Syrup - Fairdyl.

On being asked he failed to produce any document in support of stocking the above drugs. On thorough interrogation, the above noted apprehended person disclosed that Jhantu Chakraborty @ Bitla of Bridge Kali, Jonak Saha of Arya Samity para, Pintu Dey Sarkar S/O Lt. Anil Dey Sarkar of Mongalpur, Rinku Dey Sarkar S/O Lt. Sushil Dey Sarkar of Hossainpur all of Balurghat PS including his father use to stock Codeine Phosphate & Chlorpheniramine Maleate Syrup — Fairdyl into their house for smuggling into Banlgadesh through Hili boarder side illegally. Accordingly, I seized and label the above recovered drugs and other articles in presence of Sri. Dipankar Roy, WBCS(Exe.), Executive Magistrate, witnesses and above noted apprehended person under proper seizer list duly signed by them and witnesses from 21:35hrs to 22:25hrs on 27.04.2022 and arrested the above noted apprehended person.

From the facts & circumstances it is evident that the above noted arrested person along with Jhantu Chakraborty @ Bitla of Bridge Kali, Jonak Saha of Arya Samity para, Pintu Dey Sarkar S/O Lt. Anil Dey Sarkar of Mongalpur, Rinku Dey Sarkar S/O Lt. Sushil Dey Sarkar of Hossainpur all of Balurghat PS including his father use to stock Codeine Phosphate & Chlorpheniramine Maleate Syrup – Fairdyl into their house for smuggling into Banlgadesh through clandestine route of Hili boarder. He also disclosed that they have smuggled Phensedyl into Banlgadesh illegally earlier in this manner.

I, therefore pray before your kind authority that a specific case under proper section of law may kindly be started against the arrested person namely Subhankar Barman @ Subho (19) S/O Gopal Barman of Hossainpur Sanyas Colony, PS- Balurghat, Dist- Dakshin Dinajpur and his associate namely 1) Jhantu Chakraborty @ Bitla of Bridge Kali, 2) Jonak Saha of Arya Samity para, 3) Pintu Dey Sarkar S/O Lt. Anil Dey Sarkar of Mongalpur, 4) Rinku Dey Sarkar S/O Lt. Sushil Dey Sarkar of Hossainpur 5) Gopal Barman S/O Dulal Barman of Hossainpur Sanyas Colony all of Balurghat PS and oblige.
